


Budget for Sales Tax Revenue for FY13-14 is \$6,600,000. On average for the past 6 years, YTD Sales Tax revenue thru August as a percentage of the total year Sales Tax revenue has been 94%. 94% of \$6,600,000 budget is \$6,208,345; the actual for YTD thru August of \$6,418,205 compared to \$6,208,345 calculates to an over budget amount of \$209,860 (3.4%).
