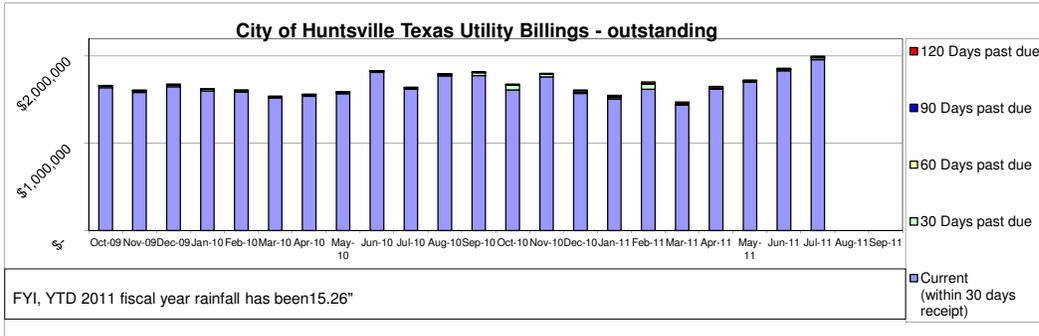

YTD, \$18,002 of accounts deemed uncollectible has been charged to the allowance for bad debt. July charge off of 20 accounts (-\$1.9) with \$2 recoveries.
