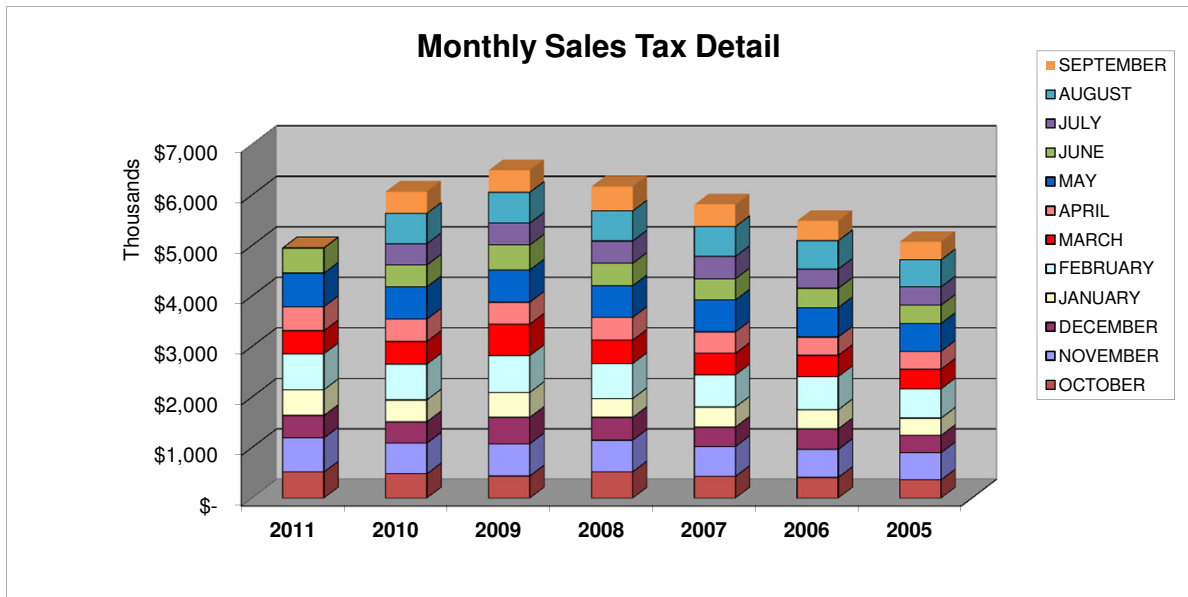
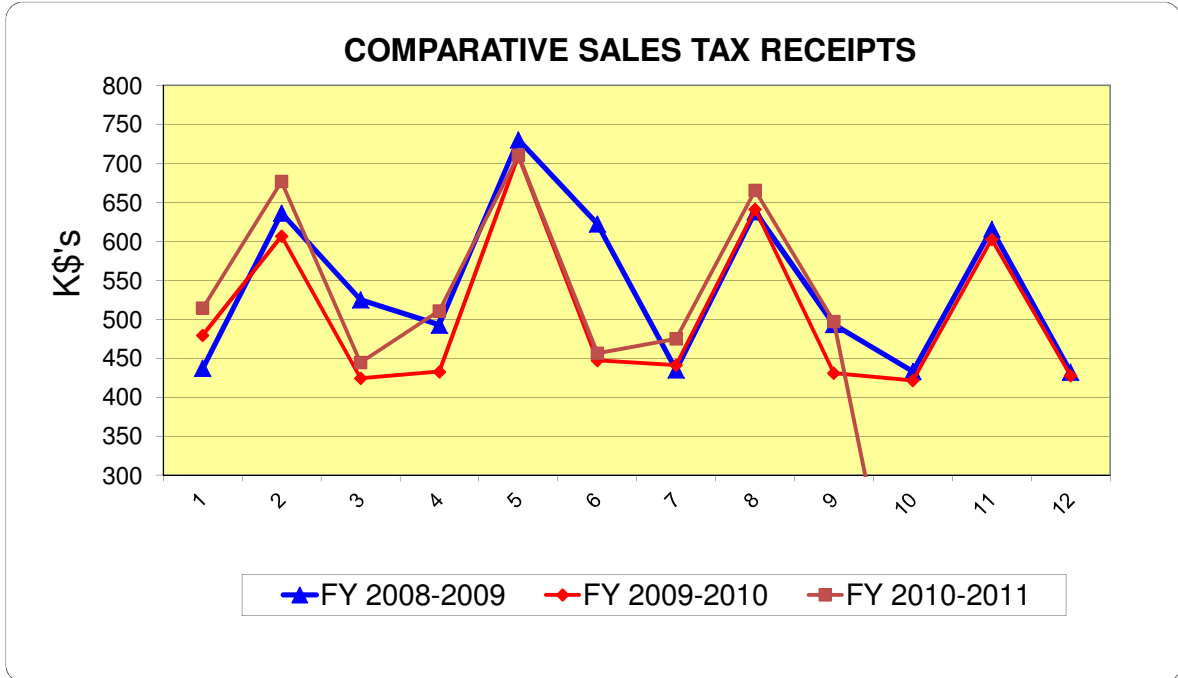

Budget for Sales Tax Revenue for FY10-11 is \$6,200,000. On average for the past 6 years, YTD Sales Tax revenue thru June as a percentage of the total year Sales Tax revenue has been 75.7%. 75.7% of \$6,200,000 budget is \$4,693,400; the actual for YTD thru June of \$4,950,856 compared to \$4,693,400 calculates to an over budget amount of \$257,456 (5.5%).
