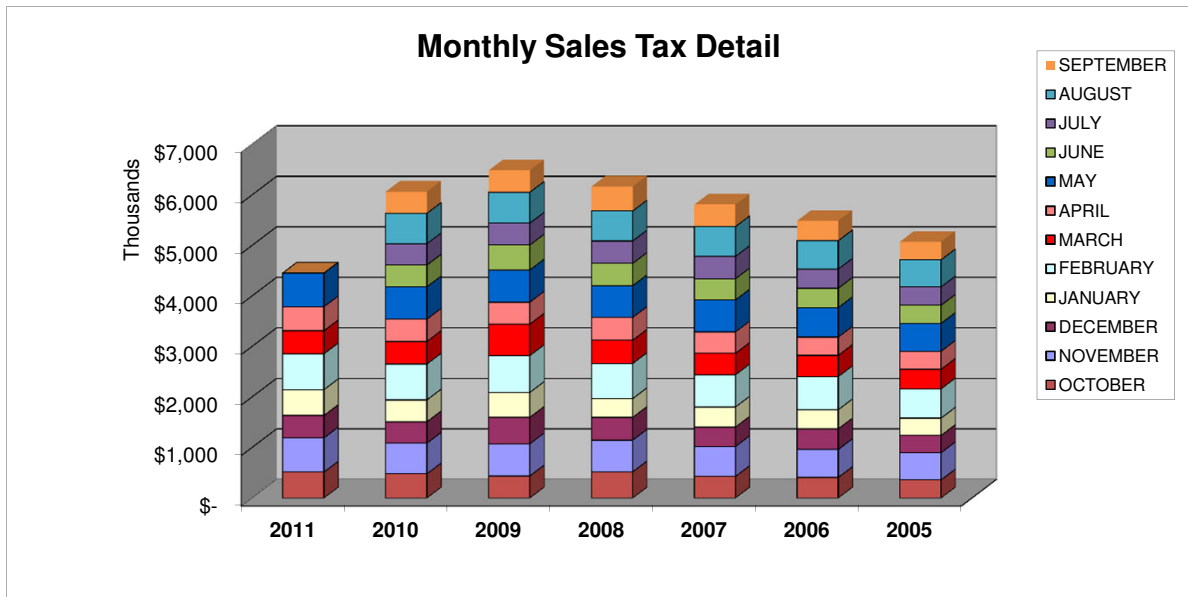
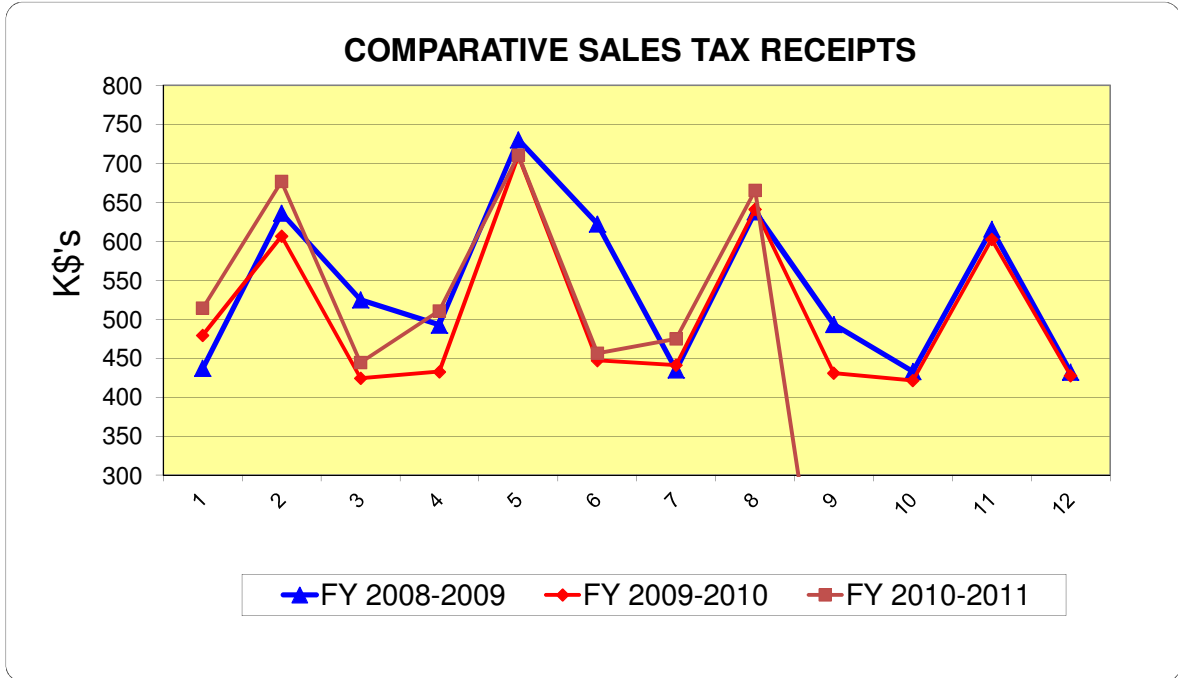

Budget for Sales Tax Revenue for FY10-11 is \$6,200,000. On average for the past 6 years, YTD Sales Tax revenue thru May as a percentage of the total year Sales Tax revenue has been 69%. 69% of \$6,200,000 budget is \$4,278,000; the actual for YTD thru May of \$4,453,703 compared to \$4,278,000 calculates to an over budget amount of \$175,703 (4.1%).
