APPLICATION FOR PERMIT

MOVING A COMMERCIAL/RESIDENTIAL BUILDING

Permit Required: It is unlawful for any person to engage in the activity of house mover as herein defined without a valid permit from the City of Huntsville for each house, building, or similar structure to be moved. A Certificate of Compliance is required for site approval if the new location is inside the city limits or ETJ.

- **Submittal Requirements:** Please submit this completed application along with the following documentation to the Permit Office at the address located at the bottom of this page.
 - o Permit fee as set forth in Huntsville Code of Ordinances
 - Certificate of Compliance and supporting documents if structure is to be moved into the city limits/ETJ.
- Approved Route: A building or part of any building shall not be moved through or across any sidewalk, street, alley, or highway within the city limits of Huntsville without receiving written approval from all agencies listed on this application.
 - The applicant/contractor shall be responsible for contacting the appropriate agencies for approval of route.
 - The applicant/contractor shall also be responsible for contacting the appropriate utilities for removing telephone, cable, and electric wires and/or poles when necessary.
- Water and Sewer: Sewer lines at previous location shall be turned up so as to terminate above ground and shall be permanently capped. Water lines shall either be turned up in the same fashion as the sewer or shall be disconnected from the meter.
- **Site Grading:** After structure is moved, the site shall be graded to drain and returned to a predevelopment condition.
