


Budget for Sales Tax Revenue for FY14-15 is \$6,824,816. On average for the past 6 years, YTD Sales Tax revenue thru August as a percentage of the total year Sales Tax revenue has been 94.5%. 94.5% of \$6,824,816 budget is \$6,448,706. The actual for YTD thru August of \$7,010,870 compared to \$6,448,706 calculates to an over budget amount of \$562,164 (8.7%).
