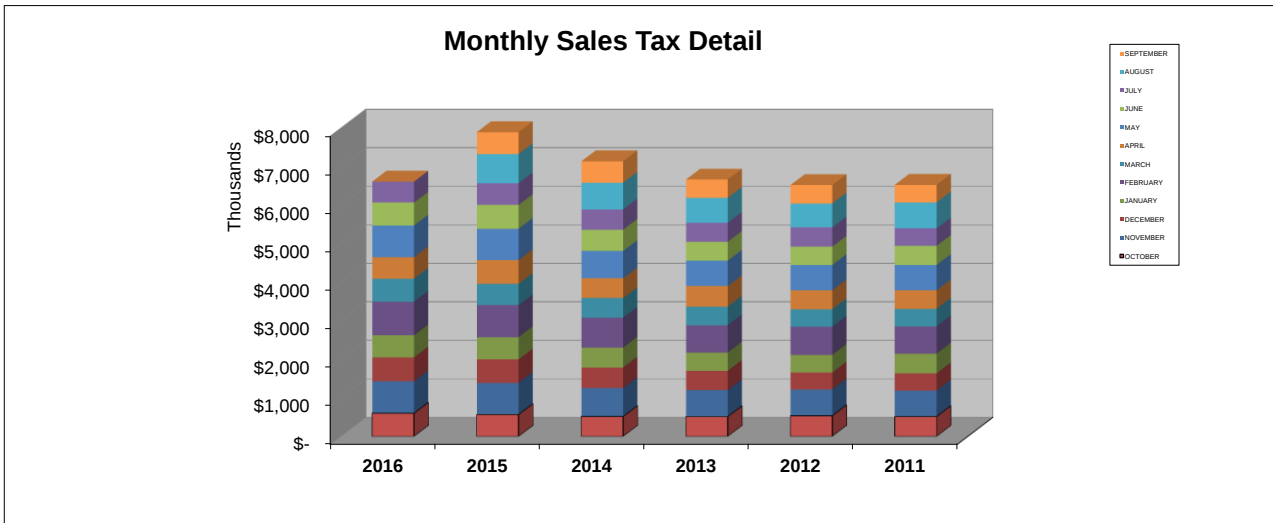
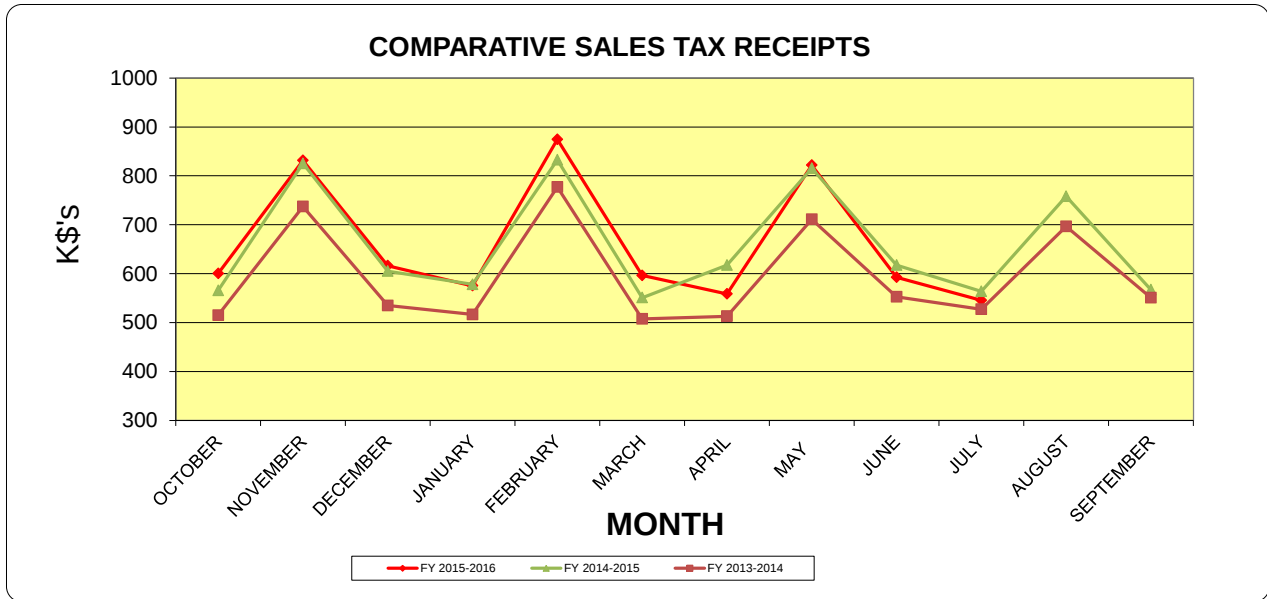

Budget for Sales Tax Revenue for FY15-16 is \$7,465,455. On average for the past six years, YTD Sales Tax revenue thru July as a percentage of the total year Sales Tax revenue has been 85%. 85% of \$7,465,455 budget is \$6,352,659. The actual for YTD thru July of \$6,269,266 compared to \$6,352,659 calculates to an under budget amount of \$83,392 (1.3%).
