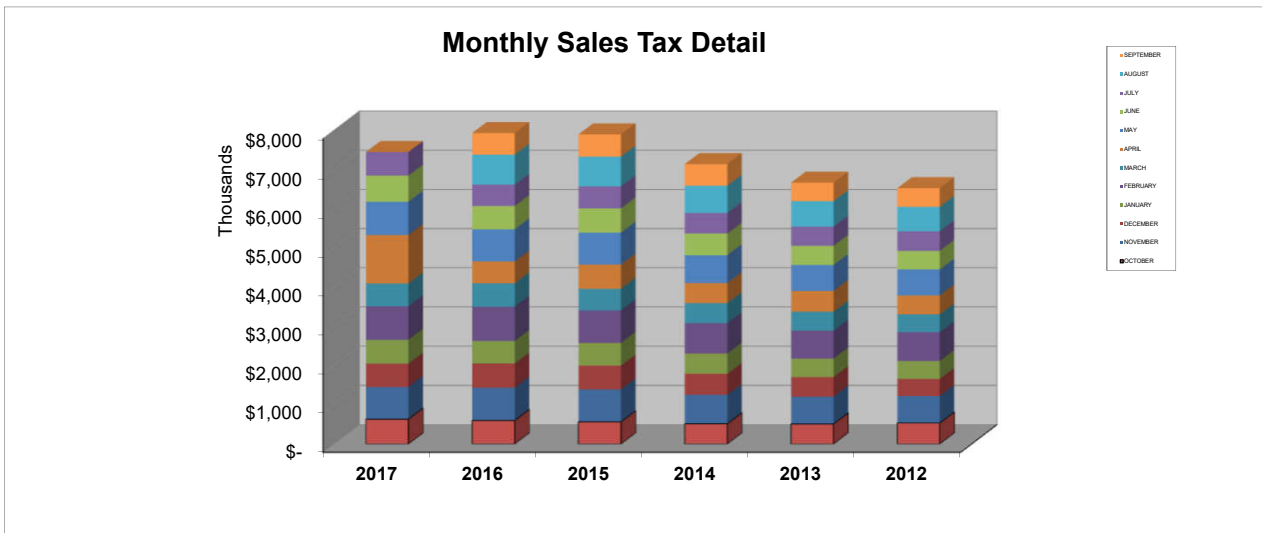
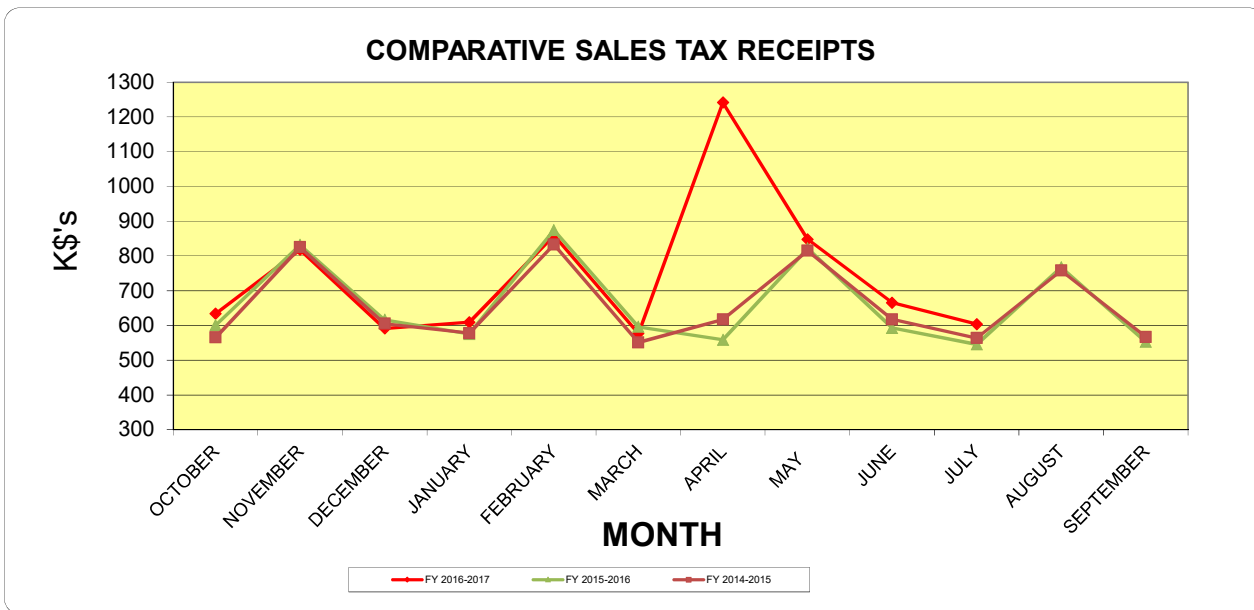

Budget for Sales Tax Revenue for FY16-17 is \$7,428,000. On average for the past six years, YTD Sales Tax revenue thru July as a percentage of the total year Sales Tax revenue has been 85.9%. 85.9% of \$7,428,000 budget is \$6,382,205. The actual for YTD thru July of \$7,083,509 compared to \$6,382,205 calculates to an over budget amount of \$701,304 (10.99%).
